**Note: During the first eleven months of the 2019, the external net financing reached a positive value representing 20,27 mln. US dollars. Considering the negative fluctuation of the US dollar exchange rate against other currencies amounting to 29,34 mln. US dollars, the external central government debt outstanding as of November 30, 2019 has decreased by 9,07 mln. US dollars or 0,54 %, compared with the external central government debt outstanding as of January 01, 2019.**
